In 2013, China announced One Belt, One Road (OBOR), an infrastructure initiative that is the modern version of the ancient East-West trade route between China and Europe. Launched with \$40 billion of initial investment, it entails construction of new or reinvigorated railways, ports and roads that will link key cities as well as hundreds of projects designed to enhance capacity within the OBOR area. This session will shed light on the geopolitical, economic and operational impacts of this ambitious initiative.

PIETER BOTTELIER

Former Chief of World Bank office in Beijing and former Professor, China Studies at Johns Hopkins School of Advanced International Studies

Pieter Bottelier, an economist and China scholar, is the author of many articles and book chapters on China's economy. He is a visiting scholar at Johns Hopkins University School of Advanced International Studies, where he served as senior adjunct professor. He also served as a senior adviser on China to The Conference Board; and visiting scholar at the Carnegie Endowment for International Peace since 2009. He also served as adjunct lecturer at Harvard University and Georgetown University.

Bottelier spent nearly 30 years at the World Bank, as senior adviser to the vice president for East Asia; chief of the World Bank's Resident Mission in Beijing; consecutive directorships for Latin America and North Africa; division chief for Mexico; resident chief economist in Jakarta, Indonesia; and handling various assignments as desk economist for East and West African countries.

Prior to the World Bank, Bottelier was employed as chief economist and marketing director of the (then) Zambian state-owned copper company (Lusaka); consultant to UNCTAD (Geneva) on the global market for virgin and scrap nonferrous metals; adviser, Ministry of Finance, Zambia (Lusaka); and at Amsterdam University.

Bottelier attended the University of Amsterdam, from which he received a Drs. degree (M.A. equivalent). He was also a guest scholar at MIT.

His new book *Economic Policy-Making in China, 1949-*2016. The Role of Economists will be released in 2018.

Futurist, New York Times Bestselling Author, Keynote Speaker and Silicon Valley Entrepreneur

Martin Ford is the founder of a Silicon Valley-based software development firm and the author of two books: New York Times bestselling *Rise of the Robots: Technology and the Threat of a Jobless Future* and *The Lights in the Tunnel: Automation, Accelerating Technology and the Economy of the Future. Rise of the Robots* received the Financial Times/ McKinsey Business Book of the Year Award and was named one of Business Insider's Best Business Books of the Year.

He has over 25 years of experience in computer design and software development, and holds a computer engineering degree from the University of Michigan, Ann Arbor and a graduate business degree from UCLA. He has written for publications including *Fortune, Forbes, The Atlantic, The Washington Post, Project Syndicate, The Huffington Post* and *The Fiscal Times.* He has also appeared on numerous radio and television shows, including programs on NPR and CNBC, appeared at this year's TED 2017 conference.

David Bach is Deputy Dean & Professor in the Practice of Management at the Yale School of Management. An expert in political economy, his research and teaching focus on businessgovernment relations, nonmarket strategy, and global market regulation. At Yale SOM, he teaches a core MBA course on State & Society as well as an elective course on Nonmarket Strategy.

As a member of Yale SOM's senior leadership team, Dean Bach directs the school's Executive MBA and the newly established Master in Advanced Management; spearheads engagement with the 29-school strong Global Network for Advanced Management; catalyzes curricular innovation in the area of global business; guides online education initiatives; and oversees Yale Center Beijing.

A winner of multiple teaching awards, Bach was named one of "40 under 40" business school professors by Poets & Quants, one of the "Top 50 business school professors on twitter".

Bach is frequently quoted on topics including the international economy, financial markets, business-government relations, and innovation in management education in outlets such as the *Financial Times, The Economist, New York Times, L.A.
